## 2025 Planned Parenthood Facilities Report

#### **Executive Summary**

When STOPP last reported the number of operational Planned Parenthood facilities in 2021, the abortion organization had seen a slight increase from 563 to 567 open brick-and-mortar facilities in just one year. Within the last four years, however, 66 facilities closed permanently, 10 temporarily closed, and 20 new locations have opened, bringing the new total of open brick-and-mortar facilities to 509 (see Tables 1, 2, 3, and 4).

Planned Parenthood's business model and facilities continue to make abortion their top priority. However, the landscape has changed in our post-*Dobbs* America, and the abortion giant is now capitalizing on its distribution of abortion pills to women, not only through the facilities themselves but through telehealth visits, its phone app, and its new virtual health centers.

The number of Planned Parenthood facilities that offer surgical abortions slightly decreased over the past four years, from 176 in 2021 to 167 facilities in 2025. The number of facilities that offer pill abortions as the only type of abortion slightly decreased from 215 in 2021 to 205 in 2025. While the total number of facilities has decreased in the past four years, Planned Parenthood has utilized several methods to increase the availability of abortion; this includes pushing the abortion pill combination of mifepristone and misoprostol, which has become its leading method of abortion.

This report, which includes research conducted from 2022 through May 2025, will show exactly how many Planned Parenthood facilities are operational, how many have closed, and how the organization has made a concerted effort to enhance and expand its online presence.

#### Since 2024, Travel for Abortion Has Increased across Five States

With the US Supreme Court's overturning of *Roe v. Wade* in June 2022, each of the 50 states was granted power to write its own laws in regard to expanding, restricting, or eradicating abortion within its borders.

According to an April 2025 <u>report by the Guttmacher Institute</u> (the former research arm of Planned Parenthood), in 2024 approximately 155,100 mothers traveled to another state to get an abortion. Illinois, North Carolina, Kansas, and New Mexico provided the highest number of abortions for out-of-state residents.

Guttmacher's report also reveals that Kansas and Virginia both saw significant increases in out-of-state travelers for abortion from 2023 to 2024. The influx of travel for abortions is a new phenomenon in our post-*Dobbs* America, and Planned Parenthood has sought to use its facilities in states with little-to-no restrictions to expand abortion numbers.

Additionally, <u>since 2022</u> Planned Parenthood has operated a patient navigator service that <u>assists</u> an abortion-minded mother in a myriad of ways. This includes procuring financial coverage for an abortion at a Planned Parenthood facility in a pro-abortion state, planning logistics for travel and lodging, and even securing various resources for her, such as finding childcare for her other children while she travels to abort her preborn baby.

The organization <u>boasted</u> that in 2023 alone, it "helped" over 33,000 women travel out of state for abortions. The abortion giant continues to prey on the fears of pregnant women, perpetuating the lies that women need abortion and Planned Parenthood.

#### Planned Parenthood Provides Abortion Via the Internet

Planned Parenthood further expanded its abortion market by utilizing the Internet to prescribe abortion pills and send them to women through the mail or for pickup at one of its facilities or at a local pharmacy.

In 2021, as the world continued to suffer the effects of the COVID-19 pandemic, the Biden administration temporarily lifted regulations on mailing abortion pills through the postal service so that women could have abortions without in-person appointments. Then in 2023, the FDA permanently removed regulations on mailing abortion pills throughout the United States, making it easier for both the abortionist to distribute the pills and for mothers to obtain them. Additionally, shield laws in seven states allow abortionists to legally provide abortion pills via telehealth to women who live in states with more restrictions.

As we see below, Planned Parenthood capitalized on the pandemic restrictions and on the changes enacted during the Biden administration to provide abortion pills through virtual telehealth visits, its new virtual health centers, and even through a phone app.

#### TELEHEALTH

Telehealth services are offered by individual Planned Parenthood facilities to persons who live both in and out of that facility's state. Today, 133 of the 509 Planned Parenthood facilities offer telehealth specifically for abortion pills.

Planned Parenthood of the Heartland (now <u>Planned Parenthood North Central States</u>) provided its first telehealth abortion <u>in 2008</u>. By the end of 2010, <u>15 of this affiliate's facilities offered telehealth abortions</u>. Over the next decade, Planned Parenthood rapidly expanded this service to other affiliates, providing abortion pills via telehealth in <u>16 states by 2019</u>.

Planned Parenthood also prescribes contraceptives and gender hormone drugs to women and men via telehealth visits, boasting that as of 2023, <u>all of its affiliates</u> offer telehealth in some capacity.

#### VIRTUAL HEALTH CENTERS

With the inception of its virtual health centers, Planned Parenthood has further expanded its telehealth abortion business. There are currently 43 of these virtual health centers in 34 states, with some affiliates operating two to three in one state. Like its regular facility telehealth visits, these virtual health centers allow Planned Parenthood to prescribe birth control, abortion pills, and gender hormone drugs to an individual via a visit by phone, computer, or tablet. According to Planned Parenthood's website, the organization will either send the pills to the patient's local pharmacy or directly to the patient's home address, as long as it is located within that virtual health center's state.

The main difference between virtual health centers and telehealth visits is that the virtual health center is operated by a state's Planned Parenthood affiliate, and only customers living in that specific state can make these appointments. For example, the <u>Virginia League Virtual Health Center</u> website states that "you must be located in Virginia to receive virtual care or medications."

As explained above, Planned Parenthood's standard telehealth visits are operated by local Planned Parenthood facilities. Anyone, including persons living outside of that facility's state, can make a virtual appointment and order abortion pills, gender hormone drugs, and contraception via the mail.

A closer look at the 43 virtual health centers shows that 23 offer abortion pills, while 40 offer contraceptives. In its 2023–2024 annual report, Planned Parenthood says that 23 of its affiliates operate virtual health centers; however, its website lists virtual health centers run by an additional seven affiliates. (STOPP will continue to track the number and reach of these virtual health centers and will address the data in future facilities reports.)

#### THE PLANNED PARENTHOOD DIRECT APP

Planned Parenthood's <u>Direct</u> app is another way the organization makes its abortion money while facility numbers decline. Depending on the state, women can simply order contraception and abortion pills through the app.

- Request a service
  It's simple! Choose your service, complete a health questionnaire, and submit your request.
- Clinical review
  A Planned Parenthood provider will review your questionnaire and message you in the app if they have any questions.
- Get your medication
  If eligible, your medication will be shipped to you in discreet packaging or sent to your pharmacy.

Due to the app's 2019 launch, the abortion business was ready to go during COVID-19's global shutdown in 2020. This created a virtual avenue for women to obtain abortions without visiting a facility. According to Planned Parenthood Direct's website, the Direct app is now available in 44 states and Washington, DC.

STOPP's research found that contraception is available in all of the Direct app locations, while abortion pills are currently available in seven states and DC. However, the sale of <u>ella pills</u> on the Direct app in 35 states and DC is also worth noting. Just this year, <u>researchers claimed</u> that this "emergency contraceptive" pill could potentially be used in place of the abortion pill mifepristone. This is one more way that Planned Parenthood can work around abortion restrictions to kill preborn babies.

#### **Analysis**

This research into Planned Parenthood facilities shows that, along with the decline in physical locations each year, the number of its customers is decreasing (see Table 5). However, the number of virtual facilities and health visits for abortions is increasing each year. In its most recent annual report, Planned Parenthood revealed that it provided 402,230 abortions in 2024 but failed to mention how many were committed through abortion drugs. This prompts these questions: Why is the abortion giant still not reporting the number of abortion pills distributed within both physical and virtual facilities? And what else is it trying to hide?

While it remains unknown how many preborn babies are dying at the hands of Planned Parenthood from surgical, contraceptive, and pill abortions, it is clear that Planned Parenthood has built a landscape for more abortion through apps, telehealth, and virtual health centers, even as its physical facility numbers decline.

#### **Summary of Results**

- Between 2022 and 2025, the number of Planned Parenthood Federation of America's facilities continued to decline, with 66 facility closures from January 2022 to May 2025 (see Tables 1, 2, and 3). In the first five months of 2025, PPFA saw the following closures and openings:
  - PP facilities closed in 2025: 22
  - PP facilities temporarily closed in 2025: 3
  - Pending PP facility closures in 2025: 2
  - PP facilities opened in 2025: 1
- 372 of the 509 Planned Parenthood facilities in the US offer abortion by surgical and/or pill methods, meaning 73% of its facilities commit abortions.
- Wyoming, North Dakota, and Mississippi are the only three states in which Planned Parenthood is not currently operating a physical or virtual facility.
- Alabama, Idaho, Rhode Island, South Dakota, West Virginia, and the District of Columbia have only one physical Planned Parenthood facility.
- Below are the top 12 states with the largest number of Planned Parenthood facilities:

California (109)	Washington (30)	Pennsylvania (20)	Connecticut (14)

These states account for 72% of all Planned Parenthood facilities in the US.

#### Conclusion

The numbers from STOPP's <u>last facilities report</u> through today show that Planned Parenthood's physical facilities are continuing to close across the country. Sixty-six facilities no longer exist due to the efforts of faithful warriors equipped with education and prayer. Whenever a Planned Parenthood facility closes, lives are saved and abortion becomes less accessible in the poor and underdeveloped communities the organization has targeted since its beginning. However, 20 new physical facilities have opened since 2022, showing that Planned Parenthood has not given up on expanding its physical footprint in communities across the country.

Planned Parenthood has remained cunning, as it infiltrated the virtual telehealth platform to prescribe abortion pills to women, furthering its <u>largest money-making "service."</u> To its own advantage, it has also utilized the lax abortion pill restrictions from the Biden FDA's <u>2023 REMS revision</u>, as well as the allowance for abortion pills to be sent through the mail directly to one's pharmacy or home. Planned Parenthood has created an empire that includes telehealth abortions not only from its individual facilities but from virtual health centers operated by many of its affiliates.

Our government must defund Planned Parenthood. Between 2023 and 2024, this abortion organization received nearly \$800 million in taxpayer money, which allows it to continue to build its physical and virtual presence. Cutting it off at the almighty dollar will impact its success in growing its deadly business. While our efforts at STOPP have always focused on informing individuals about Planned Parenthood, its roles, and ways to eliminate it from their communities, our work is now more crucial than ever.

STOPP will continue to lead the fight against Planned Parenthood until every single facility (virtual and brick-and-mortar) is abolished for good.

#### **IMPACT OF PRAYER**

Prayer is the most powerful tool we have in the fight to shut down Planned Parenthood. For decades, individuals and groups of faithful and prayerful people have gathered outside Planned Parenthoods throughout the country, asking for our Lord's help in shutting down these places that destroy both body and soul.

<u>Marian Blue Wave</u> members, for example, pray a weekly rosary for the end to all forms of abortion and for the closure of Planned Parenthood for good. Since 2019, MBW's prayer partners have faithfully pledged to pray weekly for these intentions and have seen nearly 105 Planned Parenthood closures since the program's inception.

40 Days for Life maintains a peaceful and prayerful presence around abortion facilities, and according to its <u>website</u>, this dedication to prayerful witness outside Planned Parenthood buildings has been instrumental in saving nearly 26,000 preborn lives since 2007.

With every Planned Parenthood facility that closes, the credit must go to God, the Creator and Fount of Life. As defenders of life, those who pray publicly or privately for the end of Planned Parenthood and abortion are acting as instruments of our Lord's goodness.

#### **Categories of Abortion**

In the facilities report, we provide information on how many Planned Parenthood locations commit abortions. Below are the various categories of abortion and the number of Planned Parenthood locations that commit each type.

**SURGICAL ABORTIONS:** These are invasive procedures in which the person committing the abortion inserts instruments into the mother's womb to cause the death of her child. Planned Parenthood currently has 167 facilities that commit surgical abortions.

**ABORTION PILL ABORTIONS (also called "medication abortions"):** In these types of abortions, the mother is given drugs to cause the death of her child. This is done using two drugs: mifepristone, which starves the child to death, and misoprostol, which induces contractions to expel the now-dead child from the womb. Planned Parenthood has 205 facilities that commit pill abortions but not surgical abortions. It additionally has 163 facilities that commit pill abortions along with surgical abortions. In total, 368 facilities offer abortion pills.

CONTRACEPTIVE ABORTIONS: Most so-called "contraceptives" (excluding barrier methods) have three means of operation. <u>Cleveland Clinic</u> explains: "The hormones in birth control pills prevent pregnancy by blocking conception, when sperm fertilizes an egg. They also cause changes in your uterus so that it can't support a pregnancy while you're on the pill." Contraceptives may prevent ovulation, thicken cervical mucus to keep sperm from reaching the egg, or "thin the lining of your uterus so that a fertilized egg [preborn baby] can't attach and grow there." This last mechanism is a contraceptive abortion.

While all but five of the 509 Planned Parenthood locations distribute products that cause contraceptive abortions, PP does not include this type of abortion in its data, as there is no way to know or count just how many babies are killed from contraceptive abortions.

**IVF ABORTIONS:** The fourth category of abortions occurs at in vitro fertilization facilities across the country. During the process of IVF, mature eggs are collected (retrieved) from ovaries and fertilized by sperm in a lab, resulting in an embryo (a new human being). Then the embryo (or embryos) is transferred to a uterus. The IVF process has a number of procedures that result in the death of preborn

children. This report does not delve into the specifics since Planned Parenthood is not yet involved with facilitating these abortions. However, it does offer <u>external referrals for IVF</u>.

#### **METHODOLOGY:** One physical address = one facility

Methods — Researchers collected data from both the national and affiliate websites of Planned Parenthood Federation of America to examine which facilities are currently in operation, what "services" they provide, and which ones offer telehealth abortions. This research also tracked the number and operations of the organization's virtual health centers. Where any discrepancies arose, researchers searched for the facilities online to determine which ones are temporarily/permanently closed or still operational.

Facilities count — Researchers encountered 13 physical locations where Planned Parenthood claimed more than one facility at the same physical address. This most frequently happened when Planned Parenthood was separating its abortion business from the rest of its services. In all cases where more than one facility was listed at the same physical address, it was simply counted as one.

Data collection period — The status of Planned Parenthood facilities is a fluid one. New facilities open, old facilities close, and specific services at facilities change on a regular basis. This report reflects the situation as of May 2025.
